## [SB1174](#) Bill Title: Tuition, Family, Posttraumatic, Stress, Suicide

Amends Section 15-1808, ARS relating to postsecondary institutions. The Arizona Board of Regents (ABOR), after verification form AZDVS that a person is a child or spouse of a person who meets the requirement prescribed, shall provide the person who qualifies, for admission with a tuition waiver scholarship at any University under the jurisdiction of ABOR.
