Budget Bills

HB2855/SB1722_amusements; 2022-2023

Makes statutory and session law changes relating to amusements necessary to implement the FY 2023 state budget by doing the following:

- Caps the fee for the privilege to operate fantasy sports contests to 10% of the fantasy sports contest operator's adjusted revenues.
- Caps the fee for the privilege to operate event wagering to 10% of the event wagering operator's adjusted gross event wagering receipts.
- Requires any revenues collected in excess of the amount appropriated from the Fantasy Sports Contest Fund to ADG be transferred to the state General Fund (GF) at the end of each fiscal year.
- Clarifies that on or before the 25th of each month, 90% of the monies deposited in the Event Wagering Fund from the previous month must be transferred to the GF.
- Continues for FY 2023, as session law, ADG's regulatory assessment of 0.5% on the amounts wagered on live and simulcast races from in-state and out-of-state wagering handled by a commercial racing permittee.
- Makes a technical change.

HB2856/SB1723 automation; 2022-2023

- Increases the IT Fund pro rata share from 0.43% of a state agency's total payroll to 0.61% of an agency's total payroll.
- Repeals inoperative statute related to the Automation Projects Fund (APF).
- Transfers all unexpended and unencumbered monies in an APF subaccount to the fund of origin after the completion of the designated automation and information technology project.
- Requires ADOA to annually report to the Joint Legislative Budget Committee on each reversion in the prior fiscal year by September 1.

HB2857/SB1724 state budget implementation; 2022-2023

Contains provisions relating to budgetary fund revisions needed to implement the FY 2023 budget, including authorizing the director of ADOA to impose on state departments, agencies, boards and commissions a deductible for each loss that arises out of a workers' compensation claim, actual or suspected data breach, security incident or security system breach.

Passed Senate Third Read by a vote of 20-8-2-0-0. Transmitted back to the House.

HB2858/SB1725 capital outlay; appropriations; 2022-2023

Makes various capital appropriations to state agencies in FY 2023. Specific to Military and Veterans HB2858/1725 does the following:

- Appropriates \$2,951,100 from the state GF to the Department of Emergency and Military Affairs as follows:
 - \$1,800,000 for additional construction monies for the Tucson Readiness Center; and
 - \$1,151,100 for fire suppression projects.
 - Appropriates the following amounts from the state GF to ADOA to distribute as follows:
 - \$2,386,600 for homeless Veterans housing:
 - States that ADOA must distribute the monies to a nonprofit organization in northern Arizona that partners with the Unites States Department of Veterans Affairs to provide affordable housing units to homeless and at-risk veterans on a historical military campus;

- \$500,000 for the Lukachukai Veterans' Multipurpose Complex:
 - Requires ADOA to distribute the monies to the Navajo Nation for costs associated with planning, designing and constructing the complex;
- Appropriates \$38,482,000 from the State Highway Fund in FY 2023 to ADOT for rehabilitating pavement on US Route 60 between Loop 101 to Loop 202.
- Removes the following State Highway Fund appropriations:
 - \$38,482,000 to ADOT to rehabilitate pavement along US Route 60 between Tomahawk Road and Mile Post 208; and
 - \$19,327,300 to ADOT to rehabilitate pavement along US Route 66 between Ashfork and Seligman.
- Appropriates \$3,000,000 from the GF in FY 2023 to ADOT to improve Ruby Road bridge near Nogales:
 - Specifies that this appropriation is not subject to JCCR review.
- Appropriates \$10,000,000 from the GF in FY 2024 to ADOT to improve State Route 97 near Bagdad:
 - Stipulates that this appropriation reverts to the GF on June 30, 2025, if ADOT does not secure federal funding on or before June 30, 2025;
 - States that this appropriation is not subject to JCCR review; and
 - Exempts this appropriation from lapsing.

HB2859/SB1726 courts; 2022-2023

Contains provisions relating to the courts needed to implement the FY 2023 budget.

HB2860/SB1727_criminal justice; 2022-2023

Makes statutory and session law changes relating to criminal justice necessary to implement the FY 2023 state budget.

- Requires the Department of Public Safety (DPS), effective July 1, 2026, to establish and maintain a new Major Incident Division (Division) subject to legislative appropriation.
- Requires the Superintendent of the Division to:
 - be selected on the basis of training and experience;
 - o have at least five years of experience in the administration of law enforcement; and
 - be a certified peace officer.
- Allows the Director of DPS (Director) to adopt rules governing the policies, procedures and administration of all activities of the Division.
- Requires the Division, when conducting investigations of critical force incidents, to use investigators who:
 - are certified by the Arizona Peace Officer Standards and Training Board (AZPOST) or who were sworn employees of a federal, state, county or local law enforcement agency;
 - have demonstrated the skills, knowledge, abilities and training as approved by the Director; and
 - have successfully completed investigative courses identified by the Director and approved by AZPOST.
- Requires investigators who were employed by a federal, state, county or local law enforcement agency to:
 - have retired or left the law enforcement agency in good standing:
 - not have been under investigation at the time or retirement or resignation from the law enforcement agency;
 - o not have retired or resigned in lieu of termination or discipline; and
 - o have been honorably discharged, if a veteran of the U.S. military.
- Requires the Arizona Department of Corrections to establish a community treatment program for imprisoned women and their children and outlines the requirements of the program.

HB2861/SB1728 environment; 2022-2023

Contains provisions relating to the environment needed to implement the FY 2023 budget.

Transmitted back to the House.

HB2862/SB1729 general appropriations act; 2022-2023

Makes session law changes relating to general appropriations necessary to implement the FY 2023 state budget. Specific to Veterans, HB2862/SB1729 does the following:

- Appropriates \$2,200,000 and 20 FTEs from the state GF in FY 2023 to ADVS to hire veteran service officers to provide services in rural tribal nations in Arizona that have communities that are located 100 miles or more from the nearest U.S. Department of Veteran Affairs service center and exempts the appropriation from lapsing. (Ongoing)
- Appropriates \$1,000,000 from the state GF in FY 2023 to ADVS to distribute to Indian tribes located in Arizona to conduct tribal ceremonies for tribal members discharged from the military and exempts the appropriation from lapsing. (One-Time)
- Appropriates \$3,640,000 from the state GF in FY2023 to the Hyperbaric Therapy for Military Veterans Fund, to be administered by ADVS. (One-Time) (Removed by Line Item Veto)
- Appropriates \$731,300 to ADVS for the purposes of providing a Nurse Hiring Incentive for the Arizona State Veteran Homes. (One-Time)
- Appropriates \$5,761,600 above the baseline from the State Home for Veterans Trust Fund to ADVS for operating costs related to the Arizona State Veteran Homes Yuma and Flagstaff.
- Appropriates \$10,000,000 from the State GF in FY2023 to the Arizona Board of Regents to provide tuition waivers for the spouses of military Veterans. (Ongoing)
- Adds footnote for the Arizona Department of Administration (ADOA) extending the lapsing date of the FY2022 appropriation for the repair of the Enduring Freedom Memorial through FY2023.

HOUSING:

- Appropriates \$60,000,000 from the state GF to the Arizona Department of Housing (ADOH) to be deposited into the Housing Trust Fund.
- Appropriates \$10,000,000 from the state GF to ADOH for the purposes of a Homeless Services Grant Pilot.

- Adds footnote establishing requirements for a grant program to municipalities and counties for a homeless support program. Requires participating local governments to provide a 50% match for any grant.
- Adds footnote requiring all monies in the \$60,000,000 Housing Trust Fund deposit to be distributed as grants not loans for projects in cities, towns and counties in the state.
- Requires \$20,000,000 of \$60,000,000 Housing Trust Fund deposit to be distributed to projects in counties other than Maricopa and Pima Counties and requires an additional \$4,000,000 of the total deposit to be distributed to Navajo and Hopi tribal lands.

GENERAL AGENCY IMPACTS:

- Appropriates \$49,140,300 from the state GF and \$61,635,400 from other funds are appropriated for a ten percent salary increase for state employees other than elected officials, judges and employees in state universities, the state Department of Corrections (ADC), the Department of Juvenile Corrections (DJC) and the Department of Public Safety (DPS) from an after July 8, 2022.
- Adds footnote requiring JLBC Staff, in consultation with OSPB, to determine and ADOA to allocate statewide salary increases, effective July 11, 2022, as follows:
 - A 10% increase for state employees (excluding universities, elected officials, or otherwise noted below)
 - A 20% increase for all ADC staff.
 - A 15% increase for all DPS staff.
 - A 20% increase for all DJC staff.
 - Additional market rate adjustments above 10% for specified agencies.
- Requires OSPB to report to JLBC on or before September 30, 2022, on the actual raises given by agency and classification. Requires agencies to allocate this pay raise by fund and line item in the FY2024 budget request as an adjustment for FY2024.
- Deletes footnote requiring ADOA to charge state agencies not more than \$10.42 per user per month for the statewide email and calendar service.

SB1729: 22 Jun 2022- Received a "Do Pass" recommendation from the Senate Appropriations Committee by a vote of 5-3-2-0. Deemed "Proper for Consideration" by the Senate Rules Committee. 22 Jun 2022- Passed Senate Democrat and Republican Caucus. 23 Jun 2022-Received a "Do Pass as Amended" recommendation from the Senate Committee of the Whole. Motion to Substitute HB2862 for SB1729 carried. Passed Senate Third Read by a vote of 20-8-2-0. Transmitted back to the House.

HB2863/SB1730 health care; 2022-2023

Contains session law provisions relating to health care needed to implement the FY 2023 budget. Specific to Veterans, HB2863/SB1730 does the following:

- Establishes a Health Care Interoperability Grant program in ADO with the purpose of providing grants for an interoperability software technology solution to support rural hospitals, health care providers and urban trauma center to reducing public and private health care costs and unnecessary transportation costs.
- <u>Requires the grantees to demonstrate proof of Veteran employment</u> and report on cost savings and effectiveness of interoperability system that requires the Department to submit a consolidated report on grantees annually.
- Defines rural counties as having a population of less than 900,000.

Adopted House and Senate Committee of the Whole Amendment

Species that DHS must also prioritize funding to universities and community colleges offering accelerated nursing programs up to 18 months in length. Exempts DHS from rulemaking requirements for FY 2023 for the purposes of addressing air ambulance service medical staffing.

SB1730: 22 Jun 2022- Received a "Do Pass" recommendation from the Senate Appropriations Committee by a vote of 4-3-3-0. Deemed "Proper for Consideration" by the Senate Rules Committee. Passed Senate Democrat and Republican Caucus. Received a "Do Pass as Amended" recommendation from the Senate Committee of the Whole. 23 Jun 2022- Motion to Substitute HB2863 for SB1730 carried. Passed Senate Third Read by a vote of 20-8-2-0. Transmitted back to the House.

HB2864/SB1731 higher education; 2022-2023

Makes statutory and session law changes relating to higher education necessary to implement the FY 2023 state budget. Specific to Veterans, HB2864/SB1731 does the following:

- Establishes the Spouses of Military Veterans Tuition Scholarship Fund (Spouses of Veterans Tuition Fund), consisting of legislative appropriations, administered by ABOR.
- Specifies that Spouses of Veterans Tuition Fund monies are continuously appropriated and exempt from lapsing.
- Directs ABOR to use Spouses of Veterans Tuition Fund monies, subject to availability, to award a tuition scholarship to a person who:
 - o enrolls in an Arizona public university or community college;
 - o is the spouse of an honorably discharged veteran of the U.S. armed forces;
 - is classified as an in-state student;
 - is an Arizona resident at the time of application and while receiving the tuition scholarship;
 - completes and submits the Free Application for Federal Student Aid for each year of the tuition scholarship;
 - complies with the standards of satisfactory academic progress of the university or community college in which the person enrolls; and
 - completes a federal Family Educational Rights and Privacy Act of 1974 release form to authorize the release of personally-identifiable information required for continued

eligibility determinations for each university or community college in which the person enrolls.

- Specifies that a tuition scholarship amount is equal to the university's or community college's tuition and mandatory fees, reduced by any federal aid scholarships, public grants or other financial gifts, grants or aid the person receives.
- Limits the tuition scholarship to four academic years or eight semesters and requires the scholarship to be used only:
 - o for a certificate, an associate degree or a baccalaureate degree; and
 - to pay tuition and mandatory fees at an Arizona public university or community college.
- Requires the spouse of a veteran to submit proof of their spouse's honorable discharge or general discharge under honorable conditions and requires the Arizona Department of Veterans' Services to verify that the person is the spouse of an honorably discharged veteran.
- Specifies that a person who meets the eligibility requirements may apply to ABOR for a tuition scholarship in a manner prescribed by ABOR and requires ABOR to verify eligibility before awarding a scholarship.
- Prohibits ABOR from awarding a subsequent tuition scholarship to a person who no longer meets eligibility requirements, until the person submits documentation showing that the person satisfies the requirements.
- Specifies that tuition scholarships must be awarded on a first-come, first-serve basis and that ABOR may not award a scholarship if there are insufficient monies in the Spouses of Veterans Tuition Fund.
- Authorizes ABOR to adopt rules to administer the tuition scholarships

- Requires ADOA to report costs associated with charging COSF rental rates to state agencies whose leases, or lease purchases, will expire in the next fiscal year on or before September 1 of each year to JLBC and the Governor's Office of Strategic Planning and Budgeting (OSPB).
- Requires each state agency to submit a quarterly report on the status of all appropriated capital projects and capital expenditures to the JLBC staff and OSPB.

- Requires the Director of Department of Veterans' Services to establish a separate subaccount in the Veterans' Donation Fund (VDF) for the deposit of donations received through the purchase of Army Scholarship plates.
- Mandates that monies from the VDF subaccount shall be annually allocated to a non-profit foundation that:
 - Has been in existence for at least twenty years;
 - Has a mission that includes providing college schoalrships to sons, daughters of those who have served honorably in the United States Army and spouses of enlisted soldiers on active duty in the United States Army;
 - Envisions increasing its fundraising and visibility to encourage more applicants to apply for scholarships and to provide larger scholarships to an increasing number of deserving applicant to both:
 - Reward Army families for the sacrifices that Army soldiers make every day to serve their nation;
 - Help the spouses and children of Army soldiers become leaders in society; and
 - Awards scholarship monies to:
 - Children of former United States Army members who were killed while serving in the United States Army or who received an honorable discharge or medical discharge.
 - Children of regular active duty, active duty reserve or active duty National Guard United States Army members in good standing.

SB 1095 property tax exemptions; statutory conformity

- Conditional on the voter approval of S.C.R. 1011 exempts, from property tax, the property of veterans with service or nonservice-connected disabilities who are Arizona residents.
- Updates the exemption amount for widows, widowers, persons with a disability and veterans with a service or nonservice-connected disability to reflect the present-day amount of \$4,188, which is statutorily required to be increased based on the average annual percentage increase in the Gross Domestic Product price deflator.
- Limits the allowable \$4,188 property tax exemption for a veteran with a service or nonserviceconnected disability who is an Arizona resident, by multiplying the total exemption amount by the percentage of the veteran's disability, as rated by the U.S. Department of Veterans Affairs.
- Updates the exemption amount for property used in trade or in business or for agricultural purposes to reflect the present-day amount of \$207,366.
- Updates the total assessment limit and the household income limit to reflect the present-day amounts.

SB 1170 (NOW: G&F; tags; permits; voter registration)

- Allows for the transfer of a Game & Fish license or permit to a minor child whose parent was:
 - Killed in action while serving in the Armed Forces of the United States;
 - Killed in the course and scope of employment as a peace officer; or
 - Killed in the course and scope of employment as a professional firefighter who is a member of a state, federal, tribal, city, town, county, district or private fire department.
- Allows the Commission to prescribe a manner of refunding the cost of a big game permit to the following individuals:
 - An active duty member of the Armed Forces of the United States who is ordered to leave this state during the time period in which the big game permit or tag is valid for the taking of wildlife.
 - A peace officer who is assigned to special duty during the time period in which the big game permit or tag is valid for the taking of wildlife.
 - A professional firefighter who is a member of a state, federal, tribal, city, town, county, district or private fire department and who is assigned to special duty during the time period in which the big game permit or tag is valid for the taking of wildlife.
- Expands the definition of qualified organization to include a nonprofit organization that affords opportunities and experiences to minor children whose parents were killed in action while serving in the U.S. Armed Forces or in the course and scope of employment as peace officers or professional firefighters.
- Requires the Arizona Game and Fish Department (AZGFD) to provide:
 - assistance with voter registration when accepting applications for a hunting, fishing or trapping license (license); and
 - an applicant with an online license application with a link to the Arizona Department of Transportation's voter registration webpage.
- Requires each AZGFD office that accepts applications for a license in person to provide a voter registration form to an applicant.
- Requires the Secretary of State (SOS) to provide AZGFD with voter registration forms and instructions to applicants to mail completed voter registration forms to the SOS.
- Requires the SOS to forward completed registration forms to the appropriate county recorder to determine eligibility of an applicant and add the names of eligible applicants to the voter registration rolls. Prohibits voter registration information that is public information and generated from applicants for a license from providing any public indication of the source of the registrations.
- Specifies that persons who act to register applicants for a license to vote are not deputy registrars. Defines department and license.

- Allows the Game & Fish Commission to limit the number or use of licenses that are issued to nonresidents or permits that are issued to nonresidents and that are not issued in a random drawing.
- Exempts the Commission from rulemaking requirements pertaining to limits on the number or use of licenses or permits that are issued to nonresidents.

- Establishes the Military Transitional Housing fund consisting of monies allocated from any federal sources, including monies provided by affordable housing legislation and unused or undesignated donations and undesignated federal monies for which military transitional housing is eligible.
- Requires the Director of the Department of Housing to administer the fund and specifies that the monies in the fund on continuously appropriated.
- Requires monies in the Fund be deposited by the Governor and be spent on newly constructed transitional housing, in cooperation with veteran owned and operated nonprofit organizations and for-profit organizations that serve military members and veterans that serve military members transitioning to veteran status.
- Requires Fund monies be spent for developing projects and programs to provide transitional housing opportunities for military members separating from the military to be housed in newly constructed housing facilities.
- Prohibits fund monies being spent on unoccupied hotels and motels designated for homeless Veterans.
- Specifies that fund monies may only be used for military members who will be separating or who have recently separated from the military.
- Allows fund monies to be spent on purchasing and constructing transitional housing facilities for military members who are transitioning into civilian life.
- Requires the Director, by September 1 of each year, to submit a report to the President of the Senate and Speaker of the House of Representatives and provide a copy to the Secretary of State that includes:
 - a summary of facilities funded during the preceding fiscal year;
 - the cost and geographic location of each facility;
 - the number of individuals who are benefiting from the operation; and
 - the purchase or construction of a facility.
- Defines *undesignated federal monies* as federal stimulus monies and monies originating from federal affordable housing legislation, the United States Department of Veterans Affairs or the United States Department of Housing and Urban Development that have not been allocated or approved for a specific purpose or project within three months after the applicable expenditure for the monies.

HB 2823 tuition waiver; veterans; felonies; eligibility

By way of background, current statute stipulates that a person who is a member or former member of the United States armed forces who received a Purple Heart citation, was a resident of the State of Arizona or was stationed in Arizona at the time of the injury that resulted in the Purple Heart citation and has a disability rating of 50% or more may received a tuition waiver scholarship except they are ineligible for a tuition waiver scholarship if that person has been convicted of a felony.

HB2823 Stipulates that an otherwise qualified member or former member of the United States armed forces is ineligible for a tuition waiver scholarship if convicted of a class 1, 2, 3, 4 or 5 felony, providing eligibility to those convicted of a Class 6 felony.

SB 1581 (NOW: housing; grants; homelessness; camping; appropriation)

- Allows the Arizona Department of Housing (ADOH) to distribute grants to a municipality or county to establish a sanctioned camping site for homeless individuals. Appropriates \$50,000,000 from monies allocated to Arizona from the American Rescue Plan Act of 2021 (ARPA) to ADOH.
- Requires a municipality or county and the sanctioned camping site, in order to be eligible to receive a grant, to comply with the following:
 - provide sanitary facilities, potable water and on-site security and implement a progressive engagement case management model;
 - o be integrated into the local coordinated entry system for homeless services;
 - o set low barriers to entry for potential homeless residents;
 - allow homeless individuals to camp and store personal property in areas designated by the operator of the sanctioned camping site; and
 - establish rules for the safety of the residents, including mental health or substance abuse evaluations and allows an individual to be removed for a violation of these rules
- Requires ADOH to establish a program, including site considerations and other operating policies and prioritize safe camping sites but allows ADOH to fund indoor encampment structures, tiny homes or similar low-cost structures that can be assembled quickly.
- Allows ADOH to disburse grant monies to a municipality, county or nonprofit organization to establish or support multidisciplinary homeless outreach teams.
- Requires a multidisciplinary homeless outreach team to be composed of at least one from each of the following groups:
 - o peer providers, law enforcement officers or mental health providers; and
 - social service providers, contract off-duty law enforcement officers or contracted security officers.
- Requires a multidisciplinary homeless outreach team to work to move individuals that are sleeping and camping in public or private places not fit for human habitation into homeless services, housing shelters or sanctioned camping sites.
- Asserts a municipality, county or designated operator of the sanctioned camping site is not liable in any civil action that arises out of the operation of the sanctioned camping site unless the claim involves intentional or grossly negligent conduct.
- Appropriates \$50,000,000 from monies allocated from ARPA to ADOH in FY 2023 to distribute as follows:
 - \$30,000,000 to municipalities or counties or a consortium of municipalities and counties to establish sanctioned camping sites for homeless individuals; and
 - \$20,000,000 to municipalities or counties or nonprofit organizations to establish or support multidisciplinary homeless outreach teams.

Adopted House Appropriations Committee Amendment

- Specifies that the municipality or county and the sanctioned camping site, in order to be eligible to receive a grant, must comply with outlined requirements at a minimum.
- Allows a municipality or county, in lieu of continuing enforcement, to demonstrate to the satisfaction of ADOH on application that unsheltered homeless individuals, outside of sanctioned camping sites, will be reduced by at least 80 percent.
- Allows ADOH to disburse grants to a municipality, county or nonprofit organization to establish or support multidisciplinary homeless outreach teams *in connection with the monies for a sanctioned camping site.*
- Directs all unexpended or unencumbers monies remaining from the appropriation to ADOH to be transferred to AHCCCS to supplement the Mental Health Block Grant on December 31, 2023.

HCR 2027 NOW: death benefit; assault; first responders

Subject to voter approval, statutorily requires Arizona to pay the difference of \$1,000,000 and the sum of any onetime death benefits received from a government entity to the surviving spouse or dependent of a first responder killed in the line of duty. Establishes a two percent surcharge on specified criminal and civil monetary penalties for the purpose of providing funding for the death benefits. Increases penalties for aggravated assault against first responders.

Adopted Senate Committee of the Whole Amendment

- Expands the definition of first responder to include Arizona National Guard members and Correctional officers at the Arizona Department of Corrections, thereby making their spouses and children eligible to receive the state death benefit.
- Caps the state death benefit at \$250,000, rather than the difference between \$1,000,000 and the sum of any other death benefits received from governmental entities.

- Requires the State Treasurer to pay the death benefit within 30 days of receiving written notice of a first responder's death from the first responder's employer.
- Requires the death benefit to be paid to the first responder's surviving spouse, or if the first responder does not have a surviving spouse, the death benefit must be divided equally among the first responder's children.
- Repeals the state death benefit and the state supplemental benefit fund on January 1, 2032.
- Specifies that the new two percent surcharge is only to be collected from the effective date of this legislation to January 1, 2032.
- Removes the delayed effective date.
- Makes technical and conforming changes.

SB 1242 nursing care; assisted living; regulation

Directs the Board of Examiners of Nursing Care Institution Administrators and Assisted Living Facility Managers, in addition to any other requirements, to require each applicant for initial nursing care instruction administrator or assisted living facility manager certification to submit a full set of fingerprints to the Board for a state and federal criminal history records check.

SB 1311 health care workers; assault prevention.

- States that it is aggravated assault if a person commits an assault knowing or having reason to know that the victim is a health care worker while engaged in the health care worker's duties and makes it a class 5 felony if the assault involves a physical injury.
- Requires health care employers, no later than July 1, 2023, to develop, implement and maintain a written workplace violence prevention plan that must be available at all times to all health care workers and contractors.
- Requires health care employers to investigate a workplace violence incident as soon as practicable and review the circumstances of the incident, solicit input from all of those involved, and document the findings, recommendations and corrective measures taken for each investigation conducted.
- Requires health care employers to provide training and education to its health care workers who may be exposed to workplace violence.
- Stipulates that the specified penalties do not apply to a person who does not have the ability to form the culpable mental state because of a mental disability.
- States language relating to the workplace violence prevention plan does not apply to the Arizona State Hospital (ASH) or other licensed facility under the jurisdiction of the ASH superintendent.
- Defines mental disability.

HB 2049 fingerprint requirements; care facilities

- Clarifies that volunteers or contracted persons of residential care institutions, nursing care institutions or home health agencies providing certain services, including *direct* supportive services must have a valid fingerprint clearance card or apply for a fingerprint clearance card within 20 working days of volunteer or contracted work.
- Prohibits a volunteer or contracted person from continuing to provide specified services including *direct* supportive services if the person's fingerprint clearance card has been suspended or revoked.
- States than an employee, volunteer or contractor of a residential care institution, nursing care institution or home health agency that is eligible for a good cause exception and provides

documentation of applying for it but has not received a decision is exempt from fingerprinting requirements if they provide specified services under direct visual supervision.

 - That an owner or employee of a residential care institution, nursing care institution or home health agency provide direct supervision of a volunteer providing specified services to residents or patients unless the volunteer has a valid fingerprint clearance card;
 - That employees of a residential care institution, home health agency or nursing care institutions, are not required to meet the fingerprint and criminal records check requirements again if that person remains employed by the same employer or changes employment within two years after satisfying fingerprinting requirements; and
 - A person who has received approval before May 7, 2001 and remains employed by the same employer is not required to apply for a fingerprint clearance card.
- Defines *direct supportive services* as:
 - Services other than home health services that provide direct individual care and that are not provided in a common area of a health care institution, including
 - Assistance with ambulating, bathing, toileting, grooming, eating and getting in and out of a bed or chair.
 - Assistance with self-administration of medication.
 - o Janitorial, maintenance, housekeeping or other services provided in a resident's room.
 - Transportation services, including van services.
 - Specifies that direct supportive services do not include services provided by a
 person contracted directly by a resident or the resident's family in a health care
 institution.

- Requires any experience rating adjustment, for workers' compensation claims involving medicalonly loss, to be applied to reduce the impact of the loss in the employer's experience modification rating.
- Permits the U.S. Occupational Safety and Health Administration (OSHA) to determine if employees have been exposed to grave danger from exposure to toxic or harmful substances

and that emergency temporary standards or regulations are necessary to protect the employees from danger.

• Conforms the civil penalties for employer violations of occupational health and safety standards to match OSHA's penalties.

HB 2449 care facilities; clergy visitation

 Requires that if a health care institution visitation policy allows in-person visitation of any kind, the health care institution must allow a clergy member to visit a resident who requests an in-person visit or consents to be visited in person for religious purposes by the clergy member, including during a declared state of emergency.

- Mandates the institution must allow clergy to visit a resident, upon request, if the resident's death is imminent.
- Allows an institution to require clergy to comply with reasonable health and safety precautions.
- States an institution is not liable to a person visiting a resident, or to the resident, for civil damages resulting from death or injury from a communicable disease resulting from the visitation provided the institution complied with health and safety precautions.
- Allows a person or religious organization to bring a civil action against the institution if clergy visitation is denied.

- Specifies that the prohibition of a government entity to require a resident of this state to receive a vaccination for COVID19 or any variant of COVID-19 does not apply to a health care institution that is owned or operated by a government entity in this state.

- Provides an exemption to health care institutions that are treating patients who have COVID-19 or any variant of COVID-19 and that determine that a direct threat exists that cannot be eliminated or reduced by reasonable accommodation.
- Requires the health care institution to determine whether an individual poses a direct threat based on the individualized assessment of the individual's present ability to safely perform the essential functions of the job.
- Outlines requirements that the assessment must entail.

• Provides a definition of terms.

- A state, county or municipal judicial department, prosecutorial office or facility, law enforcement agency or correctional facility;
- An area where firearm possession is prohibited by federal law;
- An educational institution defined in A.R.S. § 13-2911;
- A community college district or a university under the jurisdiction of the Arizona Board of Regents;
- Facilities operated by the Arizona State Hospital;
- An entity that operates a federal reclamation project; or

• A public establishment that is a vehicle or craft.

Defines "Secured Facility" as:

- A public establishment or public event that has security personnel and electronic weapons screening devices at each entrance;

- The area of a public event or public establishment that is not generally accessible to the public and has:
 - o Security personnel, or
 - Biometric, coded or employee-restricted entry to limit access.

- Stipulates that any business that requires patrons to present documentation regarding a COVID-19 vaccination status must accept either of the following:

HB 2386 health care institutions; education; abuse

Beginning January 1, 2022, requires each health care institution licensed under the Department of Health Services (DHS) to provide education and training through curriculum developed by DHS and the Department of Economic Security on the following:

- The signs of neglect and abuse, including sexual abuse
- The responsibilities of persons to report suspected neglect or abuse, including sexual abuse
- Whom to contact to report the suspected neglect or abuse; and
- A component that can be provided to families of vulnerable adults.

Contains an Emergency Clause.

HB 2387 minimum staff ratios; nursing homes

Establishes minimum staffing ratios in nursing care institutions as follows:

- One direct care staff member to every ten residents for the evening shift.
- Once direct care staff member to every fourteen residents for the night shift.

Defines "direct care staff member" as a registered nurse, licensed practical nurse or certified nurse aide who is acting in accordance with that individual's authorized scope of practice and pursuant to documented employee time schedules.

HB 2389 rulemaking review; time frame

- Changes the time period from one year to six months for an agency that the Legislature has granted a onetime rulemaking exemption to review a rule adopted by an agency to determine whether the rule should be amended or repealed.
- Repeals the requirement for an agency to publish otherwise exempt rules or provide the public with an opportunity to comment on the rules.
- Modifies the time period that an agency must propose an amendment or repeal of a rule to no earlier than 90 days after GRRC determines the rule to be materially flawed.

Adopted Senate Natural Resources, Energy & Water Committee Strike-Everything Amendment S/E Title: River Water Transfer

Limits the transference or conveyance of a claim to use fourth priority Colorado River water to specified uses in Arizona counties adjacent to the western border of Arizona.

HB 2412 open meetings; digital recordings

- Specifies that all public bodies must provide for an audio or audiovisual recording of all their meetings.

- Allows public bodies the option of posting a direct link of the audio or audiovisual recording on their website.
- Stipulates that the audio or audiovisual or direct link of the recording must be posted on its website no later than three working days after the meeting.
- Specifies that the minutes must be posted for public inspection no later than three working days after approval of the minutes.
- Requires an entity that is formed for the purpose of protecting or providing services to agricultural lands or crops to provide for the taking of written minutes and allows the entity to provide for an audio or audiovisual recording of meetings.
- Instructs an entity providing for the taking of written minutes to make the minutes available for public inspection no later than three working days following approval of the minutes and allows the posting of the minutes on its website, if applicable.
- Modifies the time period for any required posting to remain on the applicable website to three years after the date of the posting, rather than one year.

Adopted Senate Government Committee Amendment

Applies requirements related to the taking of minutes and recordings by an agricultural special taxing district to fire districts and natural resource conservation districts.

- Prohibits an employer from requiring an employee to receive the COVID-19 vaccine as a condition of employment, promotion or any form of compensation.
- Allows an employer to provide a onetime financial incentive to employees who receive the COVID-19 vaccine.

• Requires an employer in violation to pay statutory damages in the amount of \$20,000 per violation and entitles a prevailing plaintiff to reasonable attorney fees and costs.

Prohibits any governmental entity or any person doing business in this state from enforcing a student without parental consent or on an employee any requirement that the person receive a vaccination for COVID-19 or any variant of COVID-19 or wear a mask.

HB 2635 NOW: breast implant surgery; informed consent

- States that it is aggravated assault if a person commits an assault knowing or having reason to know that the victim is a health care worker while engaged in the health care worker's duties and makes it a class 5 felony if the assault involves a physical injury.
- Requires health care employers, no later than July 1, 2023, to develop, implement and maintain a written workplace violence prevention plan that must be available at all times to all health care workers and contractors.
- Requires health care employers to investigate a workplace violence incident as soon as
 practicable and review the circumstances of the incident, solicit input from all of those involved,
 and document the findings, recommendations and corrective measures taken for each
 investigation conducted.

- Requires health care employers to provide training and education to its health care workers who may be exposed to workplace violence.
- Stipulates that the specified penalties do not apply to a person who does not have the ability to form the culpable mental state because of a mental disability.
- States language relating to the workplace violence prevention plan does not apply to the Arizona State Hospital (ASH) or other licensed facility under the jurisdiction of the ASH superintendent.
- Defines mental disability.
- Applies statutory informed consent requirements for cosmetic breast implant surgery to breast implant surgery for reconstructive purposes.
