Bills Impacting Veterans/Military

Senate Bills

[SB 1024 Enduring Freedom Memorial; appropriation](#)

Allows the Department of Administration (ADOA) to use appropriated monies from the State Monument and Memorial Repair Fund (SMMRF) to alter or modify the Enduring Freedom Memorial to add additional names to the memorial. Additionally, appropriates \$21,422.91 from the SMMRF to ADOA in FY22 to alter or modify the Enduring Freedom Memorial to add additional names to the memorial.

[Adopted House Committee Amendment](#)

Adds that ADOA must use monies from the SMMRF to "alter or modify" monuments in addition to using the monies from SMMRF to maintain, repair, recondition or relocate monuments and memorials.

SB 1076 low-income multifamily housing; valuation

Requires a county assessor to value qualifying low-income multifamily residential rental property using an income-based method. Classifies, as class 4 property, low-income multifamily residential rental properties that are valued using the statutory income-based method.

Adopted House Committee Amendment

States that the restrictions listed apply to all units except employee units.

SB 1143 veterans overseas conflicts plates

Establishes the Veterans of Overseas Conflicts special plates if by December 31, 2021, a person pays \$32,000 to the Arizona Department of Transportation for implementation. Additionally, establishes the Veterans of Overseas Conflicts Special Plates Fund consisting of donations from the Veterans of Overseas Conflicts Special Plates. Monies from the fund shall be annually allocated to a Veterans of Foreign Wars entity located in this state, for the purposes of training and paying persons throughout this state where needed to process veterans’ claims for service-connected disabilities and illnesses.

SB 1172 veterans’ home facility; Mohave County

Appropriates \$25,000,000 from the State General Fund in FY22 to the Arizona Department of Veterans’ Services (ADVS) to construct and establish a veterans’ home facility in Mohave County. The appropriation is intended to be this state’s share of the costs and is not subject to expenditure for any purpose unless ADVS has irrevocable commitments from the United States government to fund at least 65% of the total costs. Contains an Emergency Clause.

SB 1260 property tax exemptions; statutory conformity

- Conditional on the voter approval of S.C.R. 1019, exempts, from property tax, the property of veterans with service or nonservice-connected disabilities who are Arizona residents.
- Inserts the correlating resolution for the conditional enactment
- Updates the exemption amount for widows, widowers, persons with a disability and veterans with a service or nonservice-connected disability to reflect the present-day amount of \$4,117, which is statutorily required to be increased based on the average annual percentage increase in the Gross Domestic Product price deflator.
- Updates the exemption amount for property used in trade or in business or for agricultural purposes to reflect the present-day amount of \$195,878.
- Updates the total assessment limit and the household income limit to reflect the present-day amounts.

SB 1312 veterans; special license plates; design.

Establishes the Veterans of Overseas Conflicts Auxiliary special plates if by December 31, 2021, a person pays \$32,000 to the Arizona Department of Transportation (ADOT) for implementation. Additionally, establishes the Veterans of Overseas Conflicts Auxiliary Special Plates Fund consisting of donations from the Veterans of Overseas Conflicts Auxiliary Special Plates. Monies from the fund shall be annually allocated to a Veterans of Foreign Wars Auxiliary entity located in this state for the purposes of using the monies to fund its charitable works.

SB 1327 tax credit; affordable housing

Establishes the Affordable Housing Tax Credit (Tax Credit) and outlines requirements for the Tax Credit.

SB 1331 veterans’ income tax; exemption

Increases the maximum subtraction from Arizona gross income for veteran benefits, annuities and pensions from \$3500 to the full pension amount for taxable years beginning from and after December 31, 2020. Contains a retroactive date of January 1, 2021.

SB 1360 G&F; veterans; hunting; fishing; licenses

Allows a Veteran of the Armed Forces who has a complimentary license to transfer a permit or tag to another person for the purpose of assisting the Veteran in the taking of wildlife or taking wildlife on behalf of the Veteran as the Veteran’s proxy. Additionally, provides reduced license fees for a Veteran who has been a resident of this state for one year or more immediately before applying for the license and a nonresident license for the same fee as a resident license to a veteran or military member who is not a resident of this state.

Adopted Strike-Everything Amendment

Subject: task force; G&F; veterans; licenses

Establishes the Veterans' Assistance for Licensing Outdoor Recreation Task Force consisting of the following members:

- Three member of the Senate, two of whom are appointed by the President of the Senate and one of whom is appointed by the Minority Leader of the Senate.
- Three member of the House of Representatives, two of whom are appointed by the Speaker of the House and one of whom is appointed by the Minority Leader of the House.
- The Director of Game & Fish or the Director's designee.
- One representative of a statewide organization representing Veterans who is appointed by the President of the Senate.
- One representative of a statewide organization focusing on wildlife conservation or wildlife management who is appointed by the Speaker of the House.

Requires the Task Force to make recommendations regarding hunting and fishing license fee reductions for Veterans of the United States Armed Forces.

SB 1411 NOW: unemployment insurance; benefits; duration; fund

- Increases the maximum weekly unemployment benefit amount (WBA) to:
 - \$320 on the general effective date; and
 - \$400 beginning July 1 following the date the Department of Economic Security (DES) determines Arizona meets the federal criteria to receive an interest-free unemployment insurance loan.
- Increases the amount an individual may earn with no reduction to their WBA (income disregard) from \$30 to \$160
- Increases the state unemployment tax taxable wage limit from \$7,000 to:
 - \$8,000 in calendar year 2022; and
 - \$9,000 in calendar year 2023

Prescribes requirements for the DES to obtain employment and income information and reduces, effective January 1, 2022, the maximum duration of benefits, if Arizona's unemployment rate is less than six percent.

SB 1443 military family relief fund

- Expands eligibility criteria to include a service member of an applying family who has established residency in this state and be able to provide proof of continuous physical presence in this state for at least twelve months before submitting an application.
- States that the financial need must be a result of the service member's military service.
- Establishes a deployment date requirement of on or before September 11, 2001 for applications to the Pre-9/11 MFRF subaccount and after September 11, 2001 for applications to the Post-9/11 subaccount.
- Allows the Director to allocate up to ten percent of the donations received for the actual reasonable costs of administering the subaccounts and the financial assistance program including the hiring of an employee to process applications and provide support to the committee
- Defines "established residency" and "continuous physical presence".

SB 1447 military installation fund; property conveyance

Allows the Arizona Department of Emergency and Military Affairs (DEMA) to sell, convey, lease or sublease any property, related infrastructure or improvement acquired for the preservation or enhancement of military installations.

Makes technical corrections.

SB 1514 appropriation; emergency shelter beds; seniors

- Appropriates \$5,000,000 from the state General Fund in FY 2022 to the Department of Economic Security for emergency shelter beds in western Maricopa County for seniors.
- Requires DES to distribute the monies to a single Arizona nonprofit provider that meets the following requirements:
 - experience in sheltering 400 or more homeless individuals nightly in temporary shelter;
 - at least 10 years of experience working with the chronically homeless in Maricopa County;
 - experience in providing housing placement services under the Housing First Model; and
 - participation in the Coordinated Entry System pursuant to the requirements of the Maricopa Regional Continuum of Care.

SB 1559 Native American veterans; tax settlement

Extends the amount of time that the monies in the Veterans' Income Tax Settlement Fund revert to the State General Fund from June 30, 2021 to June 30, 2024 and the amount of time that Arizona Department of Veterans' Services will accept applications from December 31, 2019 to December 31, 2022.

SB 1802 NOW: holiday code talkers day

Establishes August 14 as “National Diné, Hope and Indigenous Code Talkers Day,” and requires, if National Diné, Hopi and Indigenous Code Talkers Day falls on a day other than Sunday, the Sunday following August 14 to be observed as the holiday.

Modifies the name of the proposed holiday to be National Navajo Code Talkers Day, instead of National Diné, Hopi and Indigenous Code Talkers Day.

SCR 1019 constitutional property tax exemptions

Subject to voter approval, amends the Constitution of Arizona to repeal sections relating to property tax exemptions and replaces the sections with one consolidated property tax exemption section and allows the Legislature to exempt the following:

- Property of an educational, charitable or religious association or institution that is not used or held for profit;
- Personal property that is used in a trade or business or for agricultural purposes;
- Cemeteries that are set apart and used to inter deceased human beings;
- The property of a widow or widower who is an Arizona resident;
- Property of an Arizona resident who is at least 18 years-old and has a medically certified total and permanent disability; and
- The property of an honorably discharged veteran who is an Arizona resident with a service or non-service-related disability as determined by the United States Department of Veterans Affairs.

SCR 1027 property tax exemption; veterans; disabilities

Subject to voter approval, constitutionally exempts the property of a veteran with a service-connected disability, the veteran's spouse or the unmarried surviving spouse of a veteran with a service-connected disability from property tax.

House Bills

HB 2109 bingo; conduct; licenses

Removes the prohibition relating to conducting a lottery or raffle within a 12-hour period before or after a bingo occasion or game and increases the gross receipt amounts for each license classification as follows:

- Class A license, from \$15,600 to \$75,000;
- Class B license, from \$300,000 to \$500,000; and
- Class C license, from \$300,000 to \$500,000.

Increases the threshold amount for cash prizes to be paid by check from amounts over \$150 to amounts over \$1,100.

- Stipulates that the specified penalties do not apply to a person who does not have the ability to form the culpable mental state because of a mental disability.
- States language relating to the workplace violence prevention plan does not apply to the Arizona State Hospital (ASH) or other licensed facility under the jurisdiction of the ASH superintendent.
- Defines mental disability.

HB 2759 rulemaking; petitions; GRRC

Requires the Governor's Regulatory Review Council (GRRC) to review the practice, policy, rule, or requirement on receipt of a petition to review an existing agency practice, substantive policy statement, final rule, or regulatory licensing requirement that the petitioner alleges violates state law, is not authorized by statute, is unduly burdensome or is not demonstrated to be necessary to fulfill a public health, safety or welfare concern.

NOTE: Currently, GRRC is required to review the petition only if the practice, policy, rule or requirement applied to a profession for which the average wage in that profession in Arizona does not exceed 200 percent of the federal poverty guidelines for a family of four.
